Second: Such Registration Day will be held at Village Hall from 12:00 p.m. to 5:00 p.m.  
Third: Voting for the forthcoming election shall be conducted at the Village Hall/Community Room, 115 Main Street, Altamont, NY on Tuesday, March 16, 2021 from 12:00 p.m. to 9:00 p.m.
2. Consider approving the following individuals as Election Inspectors for Village Election Registration Day, March 6, 2021 and Village Election, March 16, 2021; Patricia Dover, Chairperson at \$13.50 per hour; Deborah Hext, Mary Hillmann, Pat Glennon, and David Grapka at \$13.00 per hour. Germaine Rexford, Alternate Election Inspector, at \$13.00 per hour.
3. Consider request to grant permission to Albany County Board of Elections to tabulate election results including absentee ballots for Village Election on March 16, 2021.
4. Consider approving Memorial Day Parade along the Village streets on May 23, 2021 at 2:00 p.m. per request of the Altamont Parade Committee. If COVID-19 restrictions disallow marching, parade will be a reverse parade with details TBA.
5. Consider holding a Public Hearing on March 2, 2021 at 7:00 p.m. to consider adopting Local Law No. 1 of 2021 to consider a Local Law Amending Chapter A405 of the Code of the Village of Altamont and Adopting a New Water and Sewer Connection Fee for Outside Users.
