Public Comment:

Lois Ginsberg, Long Grass Lane, reported the Victorian Holiday celebration will be held on December $9^{\text{th}} \& 10^{\text{th}}$ and encouraged the residents to attend all the events.

James Buono, Potentia Management Group, stated he has previously met with Kyle Haines, AFD Assistant Chief, and inquired if the Village has made a decision to switch over to LED lighting. Mayor Dineen stated the Village has been working with some towns on the LED lighting process. Mayor Dineen stated Trustee La Mountain has been leading the LED project and recommended that Mr. Buono and Trustee LaMountain speak after the meeting.

Jeremy Rosenthal, Maple Avenue, stated he could be a source of information for the Village on the LED lighting project.

Kristen Casey, Main Street, inquired about what the process is and when will the residents be able to give input on the LED lighting in the Village. Mayor Dineen stated the Village of Altamont, Village of Voorheesville, and Town of New Scotland have just started the process. They have talked to two companies regarding cost analysis.
