Mayor Dineen called the meeting to order with the Pledge of Allegiance.

Mayor Dineen reported in mid-February the Pollards and Home Front Café hosted veterans for the 75th anniversary of Iwo Jima. Mayor Dineen stated she was able to spend time with them and help serve breakfast along with Amy Anderson from the fairgrounds and it was a packed house. Congressman Tonko was there along with tons of Altamont residents. Mayor Dineen thanked the Pollards for all that they do and for supporting the veterans in the area and she stated it was a wonderful breakfast.

Kyle Haines, Chief Altamont Fire Dept., stated on April 25th the fire department will be conducting a large training exercise at Altamont Elementary School. There is going to be roughly 13 different agencies involved in the training. The public is welcome to attend. Notifications will be going out by letters to residents on Grand Street and Fairview Avenue along with sending out Nixle alerts. Chief Haines submitted Chief's report for February. Jeffrey Moller, Supt. of Public Works, reported the department finished reading water meters. Last month they painted in the community room and the fire department truck bay. An inground sand filter was removed from one of the buildings in the wastewater plant and sent to the scrap yard. The sand filter was discontinued with the sewer plant upgrade. Next week the department will fill in the area that held the old sand filter. A garage door will be installed in the filter building. Some of the space in that building will be for small equipment storage. The department was been inspecting manholes to cut back on the I&I with the groundwater coming in and they have been working on vehicles and equipment.
