Mayor Dineen called the meeting to order with the Pledge of Allegiance.

Keith Lee, Co-Chairman of the Parks Committee, thanked the Village Board for hiring an additional gardener for the Village. Mr. Lee stated he met with the gardeners two weeks ago and discussed the assignments for Bozenkill Park.

Mayor Dineen reported it was a busy month for the VFW and the American Legion. They held ceremonies towards the middle and end of May for both Loyalty Day and Memorial Day. It was raining on Loyalty Day so attendance was down a bit but it was a very nice ceremony honoring veterans who are giving back again as EMS, police officers, firefighters, or politicians. Students were there reading their essays on America. Mayor Dineen stated there was a new ceremony this year in Orsini Park focusing on WWI. A flag was dedicated and given to Cindy Pollard for the Home Front Café. Mayor Dineen, on behalf of the Village Board, thanked the VFW and the American Legion members for their hard work and for giving of their time.
