- d) Three photographs of applicant (2" x 2" taken within 30 days of the application. Such photographs shall show the head, full face and shoulders of applicant. One copy of photograph shall be attached to application, one to the license and the third shall be delivered to the Village of Altamont Commissioner of Public Safety
- e) Vehicle identification number
- f) Photocopy of applicant's drivers license

18. An applicant intending to use employees for peddling or soliciting in the Village of Altamont shall with respect to each such employee fill out on a separate form items 1 through 14 and 17d, e and f.

* NO LICENSE SHALL BE ISSUED AUTHORIZING PEDDLING BY ANY PERSONS UNDER THE AGE OF 18 YEARS

*THE LICENSE SHALL BE NON-ASSIGNABLE AND UPON REQUEST SHALL BE PRODUCED AND EXHIBITED TO ANY POLICE OFFICER OR PERSPECTIVE CUSTOMER OF THE LICENSE

*NO LICENSE SHALL BE VALID FOR A PERIOD OF MORE THAN 120 DAYS FROM THE ISSUANCE DATE AND IN NO EVENT SHALL IT BE VALID AFTER THE LAST DAY OF THE YEAR IN WHICH IT IS ISSUED
