# UPDATE ON DEC MANDATE TO UPDATE WASTE WATER TREATMENT PLANT

The New York State Department of Environmental Conservation (DEC) has been monitoring the operation of the Wastewater Treatment Plant for many years. In March 2010, DEC placed the Village under an Order on Consent citing violations involving the overflow of untreated sewage during the previous two years. The Order on Consent mandated the Village to submit and implement a plan on the needed upgrades to the Wastewater Plant to correct the problem, with a completion date no later than June 2013. Prior to DEC's actions, the Village Board has been studying and planning the implementation of a major improvement project of the Wastewater Treatment Plant which was integrated into the plan submitted to DEC. The improvement project will increase the processing capacity of the Plant to treat the inflow of sewage, and eliminate the occurrence of untreated sewage being discharged during weather related, high water events, which is unacceptable to DEC. The decision and reports on the project have been discussed in monthly Board meetings, and reported periodically by the local media during the past few years.

The capital improvement project will include the installation of new equipment to increase the scope of the biological treatment process, and the replacement of aging and inefficient equipment. The estimated cost of the project is \$ 3,510,000. The Village has secured low interest financing for the project under the Clean Water State Revolving Fund.

At its May 2012 meeting, the Village Board awarded contracts to three contractors to perform the project work.

It is expected that the work will begin this June and should be on

schedule for completion in June 2013.

Completion of this capital project will replace the aged Wastewater Treatment Plant with one that has new and modern equipment capable of meeting DEC effluent discharge standards under its imposed mandate, and one that will meet the needs of the Village for many years. The users of the sewage system will be paying for the cost of the project spread over 20 years. Beginning in 2013, there will be a capital charge on each household's sewer bill to begin paying for the project. The capital charge is estimated to be \$ 95.00 annually which would mean \$ 47.50 a current billing period. No one welcomes an increase in user fees, but it is necessary because the Village is under a legal mandate from the Department of Environment Conservation to remedy treatment deficiencies. And it is important to keep in mind that efficient, dependable, and well-run water and sewage treatment facilities are critical to a community and its residents' quality of life.

## **Bozenkill Park Summer Programs**

The Bozenkill Park Summer Camp will begin on July 2 and continue through August 10 for children between the ages of 6 and 14. Children will be participating in this year's camp version of "Fear Factor". There is a fee of \$40.00 per child per week.

Two scholarships will be offered each week to children in need who would not be able to attend Summer

Camp otherwise. Scholarships are made possible through a grant from Albany County Department for Children, Youth and Families.

Water Aerobics with Vicky Bastian will be offered on Tuesday and Thursday evenings at 6 pm from July 3 through August 2. There is a fee of \$ 40.00.

## **News from the Archives and Museum**

The exhibition, Knowersville and the Civil War, is held in conjunction with a series of events being held throughout the region in remembrance of the 150th Anniversary of the Civil War. Displayed will be researched text panels, civil war era letters from the collections of Archives and Museum, along with loans from private collections of photographs; Civil War metals, G.A.R. Members ribbons other ephemera. Also included will be soldier's letters from the battlefield, on loan from the Guilderland Historical Society and the Knox Historical Society. The G.A.R. Member ribbons and metals of Peter Ogsbury, grandfather of Everett Rau, will also displayed.


Featured in the exhibition is the story of the 134th Regiment which camped overnight in Altamont when the village was known as Knowersville. Some 1200 men, accompanied by their families spent the night September 25th. 1862 and were fed and cared for by the early settlers living here. Another feature is the story of Catherine S. Lawrence (1820-1904), a nurse from Schoharie who encountered, while serving in a hospital in Baltimore, the seriously wounded Eddie Crouse of Knowersville. father, Dr. Frederick Crounse, of Gun Club Road was well known to Catherine and quickly wrote "Dr. Fred", who immediately went to bring his wounded son home. Unfortunately, Eddie did not survive the severe head injury and died of its effects.

Women who are descen-

dants of the honorably discharged Civil War soldiers are eligible to be members of a National Chapter. Chapters are called "Tents," each being named after a nurse who served in the Civil War. Tent # 107 of the Capital District Region is named after Catherine S. Lawrence who served so honorably. Members of Tent # 107 hosted the opening reception for the exhibition in the Village Hall on Sunday, May 20th. The exhibit will be open during regular Village Office busihours Monday-Friday, until August 17th.
